

Omen Advisory, LLC Payment Terms & Conditions

Effective: July 16, 2025

By electing to receive services through Omen, you agree to pay the Omen Fee associated with the applicable platform service. You agree to pay your Omen Fee on a monthly basis in advance (“Monthly Payment”) subject to these Terms and as further described below.

You agree and acknowledge that you are responsible for paying any and all fees, including, without limitation, the Omen Fee, that you owe pursuant to these Terms and the Advisory Agreement. You are responsible for maintaining complete and accurate billing and contact information with Omen. You acknowledge that such fees may change from time to time and will be available on the Omen Website, www.agentomen.com (the “Website”) and in the Advisory Agreement. In the event of a change in fees, Omen will provide you notice electronically on the Website. You agree to check the Website from time to time for updates to the fees applicable to you. Omen reserves the right to discount or waive any fees associated with the platform in its sole discretion.

Monthly Payment

By selecting the option to make a Monthly Payment, you agree to an initial and recurring payment of the Omen Fee at the then-current Omen Fee rate applicable to the platform tier service you select, and you accept responsibility for all recurring charges prior to cancellation, including where applicable any charges processed by Omen after the expiration of your payment card. Once you select the option to make a Monthly Payment, Omen will automatically renew your Monthly Payment for each successive monthly period. Omen will continue to automatically process your Monthly Payment each month and you will be charged for each successive monthly period at the then-current Omen Fee rate until your account is closed and the service is canceled.

Payment Terms

With respect to a Platform Tier Service, you agree that once you have expressly agreed for your Omen Fee to be charged on a recurring basis, and agreed to the amount of the recurring charges, Omen may submit periodic charges (e.g., monthly) to your eligible payment method without further authorization from you, until you provide prior notice at any time that you wish to terminate the authorization or to change your payment method. You agree that such notice will not affect charges submitted before Omen reasonably could act.

Account Closure and Refunds

To close one or more of your Omen Accounts, and/or your Platform Tier Service (if applicable) at any time, you may (i) contact Omen in the customer support chat, (ii) send an e-mail to team@agentomen.com, or (iii) through the delete account workflow in the web app or mobile app. Omen may close one or more of your Omen Accounts, and/or your Platform Tier Service (if

applicable) at any time for any reason by sending you a notice of termination by e-mail, by mail or other means of notification via the Platform.

Omen does not process refunds. Omen will continue to deliver the service until the end of the period that the customer prepaid for. The number of days in each billing period in respect of which payment is being made is calculated on the basis of a year of 360 days with 12 30-day months.

Payment Methods

You may elect to pay your Monthly Payment or Yearly Payment from one of either your Omen Account or your Funding Account.

i. Payment via Omen Account or Funding Account

Omen generally deducts the Omen Fee from either the free cash balance in your Omen Account (provided by Alpaca Securities, LLC) or from your Funding Account; however, Omen may, as necessary and in its sole discretion, sell securities in your Omen Account to generate free cash in order to deduct the Omen Fee. If all eligible payment methods you provide are declined for payment of your Omen Fee, you must provide us a new eligible payment method promptly or your access to the platform will be revoked. If you provide us with a new eligible payment method and are successfully charged, your Platform Tier Service renewal date will be based on the original renewal date and not the date of the successful charge.
